LitusGo reports: several reports have been developed throughout the duration of LitusGo, based on field surveys and research. They are uploaded on the portal and are available for any user. Examples:

- Mapping of existing vocational training methods and policies in Cyprus, Greece and Malta (LitusGo number: ISBN 978-9963-9112): a detailed mapping of the existing structures for vocational and adult training in Cyprus, Greece and Malta
- Gap analysis research (LitusGo number: ISBN 978-9963-9112-7-1): a focused LitusGo survey took place in Cyprus, Greece and Malta, based on a dedicated questionnaire that was developed by LitusGo team, in order to assess target groups' training needs and gaps of knowledge on ICZM and climate changes issues, the perception of local stakeholders and the effectiveness of policies, the transparency of decision making process and the level of stakeholder participation. - **The LitusGo Training Manual** is an innovative training product, with problem-solving orientation immediately exploitable in the entire Med-region and easily customised to accommodate the needs of other European coastal areas. The Manual has been developed in a user-friendly, modular way: it consists of 20 autonomous, self-contained and interrelated modules with clear reference on the needs of each target group.
- The Manual is available in 2 versions: the web version, included in the portal, has been developed through a wiki application in order to make it attractive, interactive and fresh. The paper version consists of 20 independent booklets, one for each module, which are distributed in one folder but can be used autonomously.
- The Manual is available in four languages: English, Greek, Maltese and Turkish.

Data Base has been developed based on local needs. It includes data in a region-specific way, on fields related to ICZM and climate changes (eg existing legal framework, meteorological, demographic and social data, land uses, archaeology-culture, natural resources, future development plans and trends, ecosystems, stakeholder participation). The e-Data Base is uploaded on the portal and it is available in English and in the local Med-languages. It incorporates a dedicated technology to allow any interested party outside the partnership to create its own Local Info e-Data Base just by introducing data to a dedicated spreadsheet.
